WAIVER AND RELEASE FROM ALL CLAIMS

I consent to the use of a jump harness in the teaching of my/my child's ice skating routines. I have inspected the jump harness and the related apparatus. I understand that a belt will be attached to my/my child's waist in order to enable a skating instructor to lift me/my child one to two feet off the ice surface in order to facilitate jump take off, rotation and landing. The rope/pulley, which is part of the apparatus, is attached to a wire that is stretched over the ice surface. I understand my/my child's hair is to be secured and that all earrings or jewelry that could get caught must be removed, before use of the harness.

In consideration of my/my child's participation in any Uxbridge Skating Club program or Basic Skills activity, I acknowledge that I understand the nature of the activity and that I/my minor child, am/is qualified, in good health and in proper physical condition to participate in such activity. I acknowledge that if conditions are unsafe, I/my child, will immediately discontinue participation in the activity.

I fully understand that skating involves risks of serious bodily injury, including, but not limited to, permanent disability, paralysis, and death and that these and other risks may be caused by my own/child's actions, or in-actions, those of others participating in the event, the conditions in which the event takes place, or the negligence of the Releases named below. I fully understand that there may be other risks either not known to me or not foreseen at this time and I fully accept and assume all such risks and all responsibility for losses, costs and damages I/my child incur(s) as a result of participation in the activity.

Uxbridge Skating Club hereby releases The Township of Uxbridge, Uxbridge Arena, its staff and agents from any and all liability for any injury sustained by any member of the Uxbridge Skating Club, its staff or anyone associated with the Uxbridge Skating Club regardless of how caused, resulting from the use of the skating harness. The Uxbridge Skating Club agrees to indemnify and save harmless the Township of Uxbridge, Uxbridge Arena, and its staff and agents from any and all, suits, demands, torts and actions of any kind which may be brought against its staff or agents for which it/they may become liable by reason of any injury, loss, damage or death resulting from, or occasioned to, or suffered by any person or any property, by reason of any act, neglect or default of the figure skating harness. I hereby release, discharge and covenant not to sue the Uxbridge Skating Club, its respective administrators, directors, agents, officers, volunteers and employees, any sponsors and advertisers of any USC event in which I/my

child participate(s) (each considered one of the Releases herein) from all liability, claims, demands, losses, or damages on my/my child's account caused or alleged to be caused in whole or in part by the negligence of the Releases. This release waiver of liability and express assumption of risk agreement does not apply to any liability, claims, demands, losses, or damages arising out of the gross negligence of, or intentional, willful or wanton misconduct of Releases. If I, or anyone in my/my child's behalf, makes a claim which does not arise from the gross negligence of, or intentional, willful or wanton misconduct of Releases against any of the Releases, I will indemnify, defend, save and hold harmless each of the Releases from any loss, liability, damage, or cost which any may incur as a result of such claim.

I acknowledge that I have read this release, waiver of liability and express assumption of risk agreement and fully understand it.
